\_\_\_\_\_ I/We agree to pay all collection costs, interest, attorneys' fees, and actual court costs related to the enforcement of this contract.

\_\_\_\_\_ I/We understand that failure to meet our financial obligation to MLCS will result in further collection processes and the student(s) not being allowed to return to MLCS until the account is made current.

\_\_\_\_\_ I/We understand and agree that if MLCS were forced to offer a distance-learning program in lieu of a classroom educational program during a school year for reasons beyond its control, my/our obligation to make the above-referenced tuition payments continue for the remainder of the academic school year.

\_\_\_\_\_ I/We understand that there will be a \$25.00 returned check fee for any returned checks to MLCS. I/We also understand that MLCS reserves the right not to accept checks from repeat offenders.

**PAYMENT PLANS**

- A. FULL PAYMENT – Pay by first day of school. If paid by first day of school, a 5% discount will apply.
- B. TWO INSTALLMENTS – Pay two payments. Due August 14th and January 15th.
- C. MONTHLY EFT – A monthly automatic withdrawal from your checking or savings account. Payments can be made on the 1st thru the 30th of the month. Starting payment date is August 1, 2020 through June of 2021. With this plan, you have a choice to make 10 or 11 monthly payments (There is a \$25.00 setup fee).

\*A late fee of \$25.00 will be assessed for late payments due to non-sufficient funds or closed accounts.

**Early Withdrawal:**

There is a \$25.00 fee for early withdrawals. The business office must be notified in writing at least ten (10) working days prior to the last date a student will attend MLCS. All charges are to be paid by the final withdrawal date.

Should you withdraw during a given month, even if your child attends only one day of that month, you will be charged for that entire month.

**Refund Policy:**

With the exception of extenuating circumstances, such as loss of employment, job relocation, or expulsion of a student, MLCS operates under a “NO REFUND” policy, which includes registration, books, tuition, and sport fees. Our obligation to staff and the purchase of materials is based on the commitment of parents at the time of enrollment. Our costs continue, regardless of your child’s attendance. In the most extreme cases, school administration may consider a refund of some amount, based on the merit of the individual situation. We expect our parents to honor the “Financial Agreement” for the entire school year.

**Athletics/Sports and Activities:**

Depending on the number of players or lack of interest, a certain sport may be cancelled throughout the year.

**Athletics/Sport Fee:**

All Elementary Sports: \$40.00  
 All Junior High School Sports: \$40.00  
 PE Uniforms: \$25.00

**Note:** *Athletic fees must be paid before your child can participate in any sport.*

**Military Service Members:** Active or honorably discharged military service member can receive a 2.5% tuition discount.
