

# **Internet Permission Slip**

Skilled research and reporting are essential components of curricular education. MLCS teachers instruct their students in appropriate research strategies when exploring information in books, magazines, encyclopedias, and a variety of online information. Note taking from multiple resources, footnoting, bibliographies, and summarizing information in a student's own words are critical research and report skills. Therefore, it is unacceptable for a student to visit one website, download the information, and use this as sole resource for a research assignment. While the purpose of providing internet access is educational, students *may* abuse the privilege and access unacceptable sites.

Requirements for internet use at Mother Lode Christian School:

- Students will be permitted to access sites selected and/or bookmarked by their teacher.
- Students are not permitted to enter a URL address.
- Recreational games of any kind are not permitted on MLCS computers.
- Students are not to enter, access, participate in or read from chat rooms, Facebook or message boards.
- Students are not allowed to download freeware, shareware or any other programs without the express permission of the MLCS staff person in charge of the computer lab/classroom computers.
- Students shall not access radio broadcasting or streaming music files and shall not play music or music CDs, DVDs or other recorded music on computer lab/classroom equipment or in the computer lab.
- Students shall not access or enter personal web pages or sites which promote personal web page development, such as Instagram, YouTube or Facebook.

#### **Computer Lab Etiquette**

- Students *will not* do anything that changes the settings on the computer in order to meet my personal preferences such as background screen colors and images.
- Students *will not* manipulate google account settings or icons so that my personal account is more easily accessible than other student's accounts.
- Students *will not* establish any bookmark bars for myself without express permission from my teacher, nor will I remove any established bookmark bars by other students without express permission from their teachers. *I will not* use *motherlodechristian.com* for personal, non-school related emails.
- Students will shut down all of my accounts to the best of my ability before shutting down the computer.
- If students find another student's account is still active when accessing the internet, *they will* respectively close down an open account to the best of my ability without tampering with their work or account settings.
- Students *will not* attempt to access other programs or settings on the computer while using it other than the ones expressly assigned to me by my teacher.
- Students are to be grateful to have access to a computer lab and will seek to make it a blessing for all students.
- I understand that if I break the rules outlined in this contract, I will lose my rights to use the computer in the lab.

Ultimately, parents and guardians of MLCS students are responsible for media and internet standards for their children. We expect our students to use school computers responsibly. The use of Mother Lode Christian School's computer system and internet access is a privilege, not a right. Consequences for violating any of the above requirements may result in the following:



- a. Loss of MLCS Internet privileges for a period of time to be determined by the principal.
- b. Parent and student conferences with the administration and Board.
- c. Suspension /expulsion from school.

This notice describes the personal information we provide to Google for these accounts and how Google collects, uses, and discloses personal information from students in connection with these accounts.

#### What personal information does Google collect?

When creating a student account, Mother Lode Christian School may provide Google with certain personal information about the student, including, for example, a name, email address, and password. Google may also collect personal information directly from students, such as telephone number for account recovery or a profile photo added to the G Suite for Education account.

When a student uses Google services, Google also collects information based on the use of those services. This includes:

- device information, such as the hardware model, operating system version, unique device identifiers, and mobile network information including phone number;
- log information, including details of how a user used Google services, device event information, and the user's Internet protocol (IP) address:
- location information, as determined by various technologies including IP address, GPS, and other sensors;
- unique application numbers, such as application version number; and
- cookies or similar technologies which are used to collect and store information about a browser or device, such as
  preferred language and other settings.

#### How does Google use this information?

In G Suite for Education Core Services, Google uses student personal information to provide, maintain, and protect the services. Google does not serve ads in the Core Services or use personal information collected in the Core Services for advertising purposes.

- For legal reasons. Google will share personal information with companies, organizations or individuals outside of Google if it has a good-faith belief that access, use, preservation or disclosure of the information is reasonably necessary to:

If you consent to your child's use of G Suite for Education, you can access or request deletion of your child's G Suite for Education account by contacting [insert contact information for school administrator]. If you wish to stop any further collection or use of your child's information, you can request that we use the service controls available to limit your child's access to features or services, or delete your child's account entirely.
